GOVERNOR KITZHABER PROCLAIMS GROUNDWATER AWARENESS WEEK

Governor Kitzhaber has proclaimed April 8-14, 1996, as Groundwater Awareness Week, to draw attention to State's goal of preventing groundwater contamination. Over 70% of all Oregonians are at least partially dependent on groundwater for their drinking water, and in many rural homes and communities groundwater is the only drinking water source. Groundwater Awareness Week is a collaborative effort of several agencies that work on groundwater protection.

USGS ALTERS STRUCTURE OF WATER INSTITUTES

This year will bring substantial changes in which research grants will be supported under Water Resources Research Act. The changes were instituted by the USGS in a effort to develop a more competitive process and to allow larger projects. Under the new rules, research funds will be pooled into four national regional competitions. The Western region will include the 13 western states (Oregon, Washington, California, Alaska, Idaho, Colorado, Wyoming, Utah, Nevada, Arizona, New Mexico, Texas, and Oklahoma). The process will require faculty in the western states to submit proposals to a regional selection committee managed through the Wyoming Water Resources Center. The total research funds for the Western region is about \$800,000. The proposal guidelines are:

no state will be guaranteed funding. Projects will be supported based upon ranking within the Western region; projects will be funded at the level of up to \$350k for one to three years (smaller projects are 1677/8encouraged);

cross-state and cross-region cross-state and cross-region projects can be proposed; your LIBRAR Ya 2:1 non-federal match will still one on stable required;

- projects are encouraged to be directed toward a list of regional needs (contact OWRRI);
- projects funded to Oregon faculty will be managed through the OWRRI program;
- project start dates must be
 between September 1, 1996 to
 September 31, 1996; and
- proposals are due to OWRRI by May 21, 1996 and will be submitted to the Wyoming Institute by OWRRI.

Contact OWRRI for a proposal package for this regional competition or a request for applications will be available on the Wyoming Water Resources Center World Wide Web site (http://www.wwrc.uwyo.edu/) under the topic New Water Center News. A proposal solicitation for the typical OWRRI research projects under Section 104b of the Water Resources Research Act will not be conducted for 1996-97.

SHOW YOU CARE - BE GROUNDWATER AWARE! Groundwater Awareness Week, April 8-14, 1996

Governor Kitzhaber has declared April 8-14, 1996, as Oregon Groundwater Awareness Week to highlight the important role this crucial natural resource plays in the lives of all Oregonians. Over 70% of all Oregonians are at least partially dependent on groundwater and in many rural communities groundwater is the only drinking water source. The recent floods caused some communities to resort to backup groundwater supplies, and forced some private well owners to treat their water. The floods of 1996 brought to light our dependence on groundwater, and how vulnerable our water supplies are to contamination.

Natural disasters can't be controlled, but as Dennis Nelson of the Oregon Health Division, points out, "It's important for all of us to understand how our daily activities can affect drinking water quality...whatever we're doing at or below the surface has the potential of impacting groundwater quality." Nelson assists communities in developing wellhead and drinking water protection programs and strongly supports citizen education efforts.

"Contaminated groundwater is difficult, costly, and sometimes impossible to clean up," says Loretta Brenner, coordinator, Groundwater Community Involvement Program, OWRRI. "Prevention of contamination must be a key goal in groundwater protection," adds Brenner. The Community Involvement Program assists agencies, public water supplies, and individuals in groundwater education.

"Oregon's Voluntary Wellhead Protection Program is a great way for communities to learn more about their own water resources and prevent contamination," says Sheree Stewart, of the Oregon Department of Environmental Quality. "Wellhead protection benefits everyone in the community and is a highly cost effective way to ensure a safe, clean drinking water supply for the future," she adds.

Groundwater Awareness Week is a collaborative effort of several agencies that work on groundwater protection.
