
OWRRI and the Oregon Department of Environmental Quality will co-sponsor the Second Biennial Nonpoint Source Monitoring Conference April 10-12 in Sublimity.

"Gravel Disturbance Impacts on Salmon Habitat and Stream Health, Volumes I and II," an OWRRI report prepared for the Oregon Division of State Lands (DSL) have been completed. The Division contracted with OWRRI to prepare the report after the 1993 Legts after passed Senate EILS1. SB 31 required DSL to conduct a story rowaniate the "effects of gravel removal or stream health," to identify critical salmon habitat, and to adopt administrative rules that require a permit for all alteration activities in these areas.

Public hearings on the report will be held this month around the State. ### Lane County: A Groundwater Guardian

Lane County, Oregon, has been selected by the Groundwater Foundation as one of fifty International Groundwater Guardian Communities for 1995. The award, given to communities actively working on groundwater protection, gives Lane County Extension Agent Ross Penhallegon and the volunteers who work with Extension Service water projects well-deserved recognition. The Lane County group will showcase their work at the 1995 Groundwater Guardian Conference, November 19-21, in Chicago.

## Groundwater Grant Funds Available

The Oregon 319 Grant Program is now accepting grant applications for 1996. Grant applications should address diffuse or non-point source pollution impacting groundwater quality. Agricultural best management practices, public education, community involvement information management and assessment, and monitoring of land activities affecting groundwater are the major grant categories. All 319 grants require a 40%, non-federal match as part of the budget. Deadline for submission of grant proposal is Tuesday, May 16, 1995. ## Groundwater Community Involvement... Alive and Well in Oregon!

The 1994 year was busy for the L Community Involvement Program, and 1995 is shaping up to be even busier. Current projects include a forum on Groundwater Quality in Benton County, Nitrate testing programs in Tillamook and Clatsop Counties (sponsored by the Soil and Water Conservation District, and Seaside High School Coastal Studies and Technology Center). Teacher training with the groundwater model, a new groundwater program brochure, and a publication: "Organizing a Free Nitrate Testing Event in Your Community" are also in the works. Upcoming projects include the development of a database for volunteer nitrate

monitoring programs and a Groundwater Communications Network.

## Groundwater Festivals Making Waves in Oregon...

Oregon's second Children's Groundwater Festival will be held Friday, April 14, at Western Oregon State College in Monmouth. This year's theme is "Dive Into the World of Water," and will feature dozens of exhibits, demonstrations, and projects on groundwater and surface water resources. Over 1,000 fifth, sixth, and seventh grade students and teachers from around Oregon will attend the free event.

The extremely popular festival has been funded by 319 Grants from the Oregon Department of Environmental Quality (DEQ) for the last two years. Next year's festival is looking for a new home and new funding base. "This is an excellent opportunity for agencies, educational institutions, and corporations to work together to bring the Groundwater Festival to students in 1996," comments Julie Magers, Festival Coordinator, Oregon DEQ, "the response from all the participants has been nothing but positive."

Coburg Elementary School hosted a "Mini-Groundwater Festival" on Friday, March 31st. Organized by the City of Coburg Public Works Department, and Lane Council of Governments, the festival featured interactive displays on groundwater movement and pollution, nitrate testing, preventing groundwater contamination, and water treatment.

Guests from Oregon Health Division, OR DEQ, Oregon Association of Water Utilities, and the Groundwater Community Involvement Program presented the topics. Over 100 students participated in the halfday event. Coburg is working on a wellhead protection project to address concerns about nitrate contamination, old septic systems, and land-use activities that contribute to groundwater pollution.


