Description of the Proposed Action:

Mr. Edson wishes to collect rocks from the lower Gerber Reservoir Area. Rock will be hand picked and brought to a pickup truck and trailer. He may use a hand truck or wheel barrow to move rock. No driving across country is allowed. He intends to collect approximately 5 tons of decorative flat lava rock to build a patio for personal use. The collection area is about 1 mile in length down the 39-13E-11, Round Valley road.
