DESCRIPTION OF THE PROPOSED ACTION (INCLUDING PURPOSE AND NEED)

This is a right-of-way for a 12.0KV overhead distribution feeder line that crosses a 9 acre parcel of land managed by the BLM. This parcel was re-conveyed back to the U.S. government for \$1.00. It does not show up on BLM LLI therefore it doesn't show as government land on the map. It has been in place and in use for about 50 years. This line will be in place and in use for the foreseeable future. This grant will be converted from the Act of 1948: 062StatT0017 Power transmission line, to a FLPMA ROW. The land contained within the right-of-way totals 0.16 acres. See attached maps.

IMPLEMENTATION DATE

This project is implemented ready for renewal for another 30 years.




Figure 2: Location of Right-of-way within the 9-acre parcel.
