Renewal of existing powerline ROW under 1911 Act. This grant will be renewed under Title V, FLPMA, section Sec. 501 (43 USC 1761) act of 1976. The new grant will state terms and conditions that will allow right of renewal of the new grant before expiration. The existing powerline has been in use for 50 years. It is located over Naylox mountain. The portion that crosses BLM ground is approximately 1 mile in length.

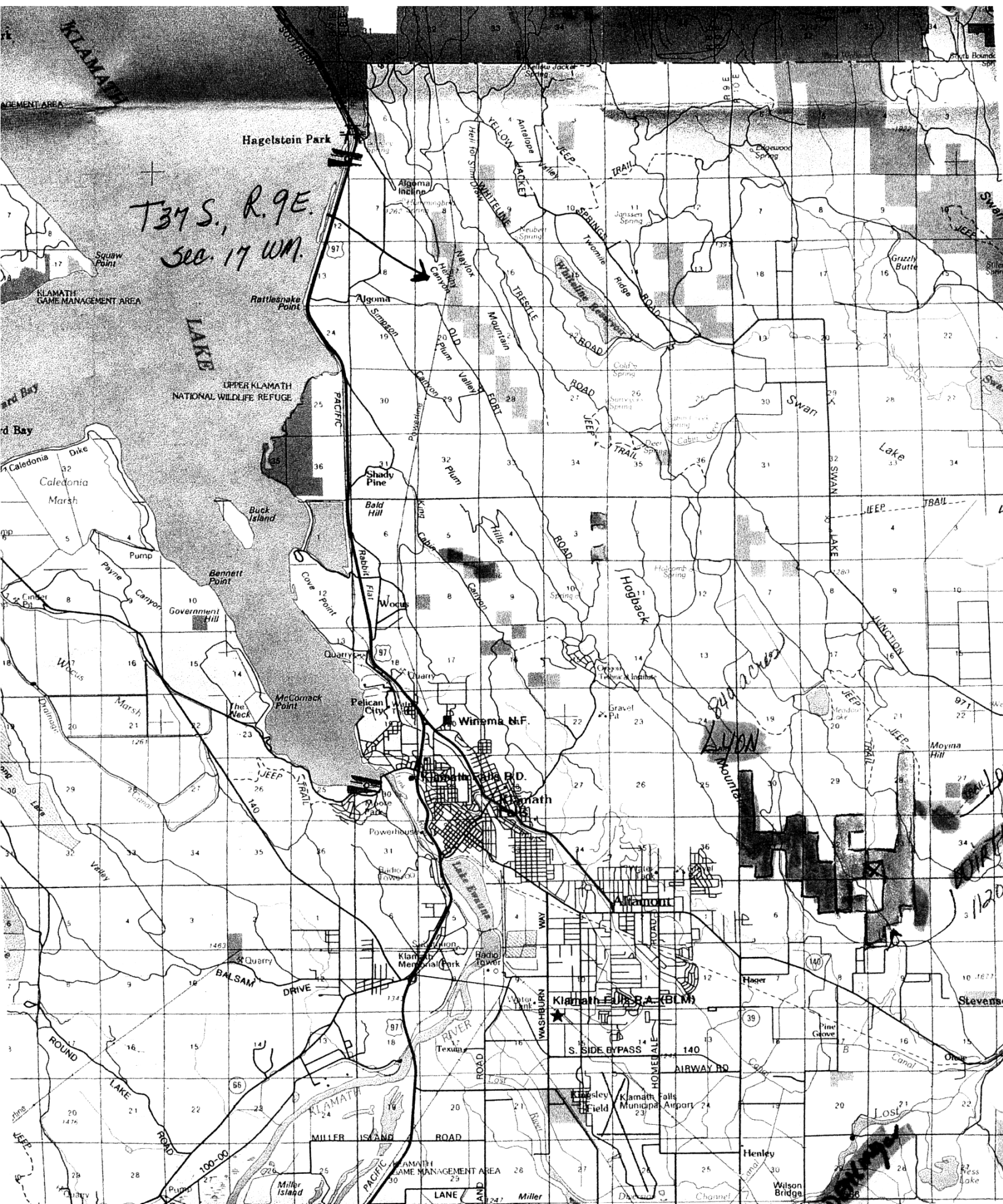
SUMMARY OF FINDINGS and CX DETERMINATION
