DESCRIPTION OF THE PROPOSED ACTION (INCLUDING PURPOSE AND NEED)

On May 3rd, 2006, the City of Klamath Falls requested cooperative assistance from the BLM - Klamath Falls Resource Area in continuing to implement the Klamath Falls Community Wildfire Protection Plan (CWPP), specifically in the area of Moore Park. BLM's participation in this effort would consist of providing equipment and personnel to conduct fuels treatment activities (mowing with a bobcat) on up to approximately 15 acres of non-federal land as shown on the following map.

The proposed action is comparable to existing fuels treatment activity or project plans prepared and implemented in the Klamath Falls Resource Area, Lakeview District, Bureau of Land Management. The types of fuels treatments proposed have been subject to analysis under the National Environmental Policy Act on Bureau managed lands. In all instances, the Bureau made a Finding of No Significant Impact and concluded no environmental impact statement was required. As per requirements of the National Historic Preservation Act (Section 106) and the Endangered Species Act, the BLM must assess the potential for impact to cultural resources and threatened/endangered species prior to the approval of any expenditure of federal funds on non-federal lands.

IMPLEMENTATION DATE

The City of Klamath Falls would like to accomplish this work during the summer of 2006.

PLAN CONFORMANCE

Although the proposed project does not have to comply with BLM plans it has been reviewed and has been found to be in conformance with the concepts of the following BLM plans, programmatic environmental analyses or policies:

- Klamath Falls Resource Area Record of Decision and Resource Management Plan and Rangeland Program Summary (KFRA ROD/RMP/RPS), approved June 1995.
- Lakeview District Fire Management Plan Phase 1 (1998)
- Wildland and Prescribed Fire Management Policy (1998)
- National Fire Plan (A Collaborative Approach for Reducing Wildland Fire Risks to Communities and the Environment 10-Year Comprehensive Strategy) (2001)

IDENTIFICATION OF EXCLUSION CATEGORY

The proposed action has been identified as a categorical exclusion under Department Manual 516 DM 6, Appendix 5.4 Section C(4) - *Pre-commercial thinning and brush control using small mechanical devices*.

The proposed action would not create adverse environmental effects or meet any of the above exceptions.

DOCUMENTATION OF RECOMMENDED MITIGATION

Note: although none of the conditions for the above exceptions are met, the resources discussed are potentially affected. Mitigation measures and Project Design Features below are applied to prevent the adverse conditions discussed in the exceptions:

Exception #7 - A cultural resource survey has been completed by a local archaeologist in Moore Park. The initial two project sites between the walking trail and the paved routes, and an additional area along the southern boundary of the park (a total of almost 79 acres) were surveyed (see attached map). The report was submitted to the Oregon SHPO. Two cultural resources sites were documented and will be avoided during project implementation.

Exception #8 - The bald eagle nest near Moore Park is approximately .41 miles from the edge of the proposed unit. A field visit was completed to assess the visual distance and potential disturbance to the nest. This activity is in compliance with the seasonal restrictions (¼ -mile or ½-mile line-of-sight) in the current programmatic fuels consultation (81450-2006-0104). As long as activities associated with this project do not occur closer to the nest no further consultation is necessary. A "No Effect" determination is made for any other T&E species.



Moore Park Fuel Treatments








Figure 2 – Cultural Resources Survey Map
