Oregon County Economic and Fiscal Trends:
1977 to 1982

The most recent recession has generated an increased interest in local economic growth and diversification. The success of local economic development efforts depends in part on the levels of public services and taxes. And the effectiveness of local efforts to diversify the economy and maintain public services depends in part on community support. This support, in turn, depends on the community understanding of the current economic and fiscal situation and how that situation developed in recent years.

With this report, local officials and citizens may be able to better understand how the current economic and fiscal situation developed and to explain this development to:

- prospective employers who are considering moving to the county,
- members of local government budget committees, who make important decisions affecting the economic and fiscal health of the community, and
- citizens who vote on tax levy measures.

Local planning and budget officials may also find the perspective useful in their attempts to improve projections for planning and budgetary purposes.

This effort to monitor economic and fiscal trends grew in part out of recent attempts to develop indicators of local government financial condition. The Advisory Commission on Intergovernmental Relations (1973), Municipal Finance Officers Association (1979), International City Management Association (Groves, 1980), among others, have developed sets of indicators that are intended to help local government officials and administrators assess the financial condition of their cities and identify emergent problems.

We have not attempted to develop a set of financial indicators for Oregon counties. Not only are the data simply not available for this effort, but there is also disagreement about the meaning of many of the indicators. An increase in expenditures per capita, for example, may occur for a variety of reasons. In some cases, a rise would be a source of concern, in others it would not be. There is no accepted "norm" for most of these indicators,

and the diversity among counties in terms of economic and financial resources, social and political characteristics, and consequent public service demands makes development of such norms a rather hazardous undertaking.

Rather, this report uses available economic and fiscal information to put the current situation — particularly with regard to population, income, employment, and taxes — into a multiyear historical perspective. Because the relationships between economic indicators (income, for example) and fiscal indicators (taxes) are quite complex, we have not attempted to work out such linkages. The data contained here, however, may permit the development and testing of hypotheses about these links.

The Economic and Fiscal Indicators

For each county in the state, and for the state as a whole, information on selected economic indicators (related to population, employment, personal income, and retail sales) and selected fiscal indicators (property taxes, and county intergovernmental shared revenues from the Federal and state government) is presented for the period from 1977 to 1982.

Population

Population figures are estimates of the number of people residing in a county as of July 1 in a given year. The Center for Population Research and Census, Portland State University, bases these figures on births, deaths, school enrollment, housing, income tax returns, medical enrollment, voter registration, and other data that reflect changes in population.

Population estimates for the years 1978-1981 have been revised using the 1980 Federal Census figures as a benchmark.

Employment

Employment, labor force and unemployment data are annual averages of monthly estimates of the number of people in each category. The reported data, compiled by place of residence, are estimates made by the Employment Division of the Oregon Department of Human Resources.

In a few cases, two or more contiguous counties are considered to make up a single labor market area. For these counties, labor force, employment, and unemployment figures are reported for the total labor market area. The Portland Standard Metropolitan Statistical Area (SMSA), which includes Clackamas, Washington, and Multnomah Counties in Oregon and Clark County, Washington, is considered to be a single labor market area. Similarly, the employment and labor force data for Marion and Polk Counties (Salem SMSA) and Wasco and Sherman Counties are combined.

Labor Force. Officially known as civilian labor force, by place of residence, this indicator includes all nonmilitary persons, 16 years and older, who are either employed or unemployed, according to the Employment Division definitions described below.

Number Employed. The employment figure is an estimate, based on a monthly survey, of the number of employed civilian persons 16 years and older, who live within the geographical area. It includes all persons who worked for pay, unpaid family workers who worked at least 15 hours in the survey week, and workers who are temporarily absent due to vacations, labor disputes, etc. Those who work simultaneously at more than one job are only counted once. Commuters are counted in their county of residence.

Percent Unemployed. The unemployment rate, called percent unemployed in this report, is the number of unemployed persons expressed as a percentage of the labor force.

The unemployed are those persons who were not employed during the monthly survey week but were available for work and had either (1) overtly engaged in job seeking activity in the 4 weeks up to and including the survey week, (2) were waiting to be recalled from a layoff, or (3) were waiting to report to a new wage or salary job within 30 days. Discouraged workers (those who wanted to work but made no attempt to find work in the four weeks before and including the survey week because of a belief that no employment was available) were not included as unemployed, as their number is not known.

Income

The income data are estimates made by the Bureau of Economic Analysis (BEA), U.S. Department of Commerce.

Total Personal Income. Total personal income is the annual income of residents of an area from all sources. It is measured after deduction of contributions to social insurance programs, but before deductions of personal taxes. Total personal income is the sum of three types of income: labor and proprietor income; dividends, interest, and rent; and transfer payments.

Labor and Proprietor Income. Referred to in recent BEA publications as net earnings by place of residence, this figure consists of total earnings by place of work minus personal contributions for social insurance, adjusted to a place-of-residence basis by accounting for income of commuters who work outside of their county of residence.

Dividends, Interest, and Rent. Dividends are cash payments to stockholders by corporations organized for profit. Interest is the monetary and imputed interest income of persons from all sources. Rent includes the monetary income of persons from the rental of real property, except the income of persons primarily engaged in the real estate business. Rent also includes the imputed net rental income of owner-occupants of nonfarm dwellings and the royalties received by persons from patents, copyrights, and rights to natural resources.

Transfer Payments. Transfer payments to persons is income from both government and business sources for which services are not currently rendered. Government transfer payments include payments under the following programs: Federal, old-age, survivors, disability, and health insurance; railroad retirement; unemployment insurance; government retirement; Federal and state insured workers' compensation; veterans' benefits; food stamps; black lung; supplemental security income, and AFDC. Government payments to nonprofit institutions, other than for work under research and development contracts, are also included. The major business transfers are corporate gifts to nonprofit institutions and consumer bad debts.

Per Capita Income

Per capita income is the total personal income of the county divided by the population of the county. In computing per capita income, we used population estimates of the Center for Population Research and Census, Portland State University.

Since income is measured as a flow throughout the year, whereas population is only measured at midyear, a significant change in population during the year may distort the per capita figures. Also, in counties with large institutional populations (e.g., prisoners or college residents), the per capita figure might be misleading.

Retail Sales

Retail sales data are estimates of annual retail sales from the Survey of Buying Power found in *Sales and Marketing Management* magazine. Retail sales includes all net sales (minus refunds and allowances for returns) for establishments engaged primarily in retail trade. Receipts from repairs and other services of these businesses are counted; retail sales by such nonretailers as wholesalers and service establishments are not included.

Retail sales estimates for 1979 and later years are not directly comparable with those in previous surveys for two reasons: 1) benchmark data and growth rates were revised as a result of the 1977 Census of Retail Trade; and 2) carrying charges, other charges for credit, and some taxes were no longer included, beginning with the 1979 data.

County Intergovernmental Revenues

County intergovernmental shared revenues are payments from the Federal and State of Oregon governments to the counties during a given fiscal year in amounts prescribed by statutory formula, usually as a percent of a tax or other revenue source. These data are compiled annually by the Association of Oregon Counties. Specifically excluded are grants in aid (payments for specified programs or projects, the levels of which are determined through appropriations bills) and interlocal revenue (payments from one local government to another, as for reimbursement or contracted services). Share revenues accounted for 78 percent of all county intergovernmental revenues in fiscal year 1977-78, and 76 percent in 1981-82.

Total county intergovernmental revenues, as reported here, is the sum of the major state and Federal county intergovernmental revenues as defined below.

County Intergovernmental Revenues, State Sources. The major State of Oregon shared revenue payments to counties are from the cigarette tax, amusement device tax, beer and wine tax, State Racing Commission revenue, state forest revenue, and highway and liquor revenues. This indicator is the sum of payments to counties from these seven revenue sources. All figures represent the amount actually received by counties with four exceptions: the 1981-82 fiscal year figures for the cigarette, highway, liquor, and beer and wine revenues consist of actual payments received through May 1982, but include estimates for receipts for June 1982.

County Intergovernmental Revenues, Federal Sources. The major Federal payments to counties are from several sources: General Revenue Sharing, O & C revenues, National Forest revenue, Payments-in-Lieu-of-Taxes, Taylor grazing lands revenue, Coos Bay Wagon Road revenues, and revenues from public land sales and mineral leases. The Federal county intergovernmental revenue measure is a sum of actual payments to counties in a given fiscal year from these sources.

Net Property Tax Levies

The net property tax levy is the total levy submitted (minus offsets) for a given fiscal year. An offset is a payment from one unit of government to another to be used to reduce the property tax levy in the receiving district. Many local governments' tax levies are reduced, for example, by offsets paid by the state out of timber severance taxes.

Two series of data on net property tax levies are included: the total of net tax levies of all taxing districts (county government, cities, school districts, fire districts, etc.) in a county and the tax levy of county government only.

Deflation of "nominal" to "Real" Dollars

In order to determine real changes in purchasing power over time, we converted those trend indicators expressed in dollar terms into 1977 dollars using an appropriate price index. The constant dollar figure allows meaningful comparison between yearly data, unaffected by the decline in purchasing power of a dollar due to inflation.

We converted income and retail sales figures using the Portland Consumer Price Index (CPI) found in the Bureau of Labor Statistics' *Monthly Labor Review*. The CPI compares the price changes in a weighted market basket of goods. The weights are assigned to commodities in proportion to their economic importance as revealed by a 1972-73 survey of urban family expenditures.

We deflated county intergovernmental revenues and property tax levies to 1977 dollars by using the implicit price deflator for state and local government purchases of goods and services, found in the *Economic Report of the President*. Thus, the constant dollar figures indicate the amount of real purchasing power these revenues provide to local governments. This price index is called implicit because, in contrast to the CPI's predetermined weights for specific items, the government price index's weights for specific items depend on the value of the expenditures for those items in the given year.

Organization of the Report

Information on the economic and fiscal indicators for the state and for each county is found beginning on page 12. The state information is presented first, followed by information on each county. Counties are in alphabetical order. Values of each indicator are presented in numerical form in the table on the right-hand page.

Graphs of the trends in each indicator are found in the figures on the left-hand page. For each of the nine graphs, the horizontal axis is the same and represents the calendar year or fiscal year. The vertical axis label is found at the top of each graph. For example, the graph at the upper right-hand corner of each page contains information on per capita income.

These graphs are structured to make it easy to compare growth rates among indicators within a county, between indicators across counties, and between the county and the state. The vertical axis of each graph has a value of zero at the origin. The vertical axis is then scaled so that the 1977 value of each indicator appears at the midpoint of this axis. (For graphs with multiple indicators, the "total" indicator begins at the midpoint; "population" begins at the midpoint on the "population, labor force, employment graph.")

Because of this structure, by studying the slopes of the top lines on each graph, you can compare growth rates since 1977 of various indicators. (Slopes can be compared for this purpose only between lines beginning at the midpoint of the graph.) Indicators with steeper slopes are growing faster than indicators with shallower slopes. By comparing the slopes, you can compare rates of growth of population, property taxes, and intergovernmental revenues, for example, since 1977.

Because the placement of these graphs on each page should be identical, you can make a transparency of any county and compare its indicators with the same indicators in other counties or the state. If you are interested, for example, in whether population or income grew more quickly in your own county than in a neighboring county or in the state, you could easily make this comparison by preparing a transparency of the graphs for your county, laying the transparency over the graphs for other counties or for the state, and comparing slopes on the variables of interest.

Note that, in the retail sales graph, the line is not continuous: there is no line between 1978 and 1979. This emphasizes the fact that the series for 1979 to 1982 is not comparable with the 1977 and 1978 estimates, because of a change in the data series between 1978 and 1979.

Note also that employment-related indicators (civilian labor force, employment and unemployment rate) for seven counties (Washington, Multnomah, Clackamas, Marion, Polk, Wasco, and Sherman) are not shown with the other indicators for those counties. This is because employment-related information collected by the state employment division does not provide county-level information for these counties. Thus, employment-related information for the Portland SMSA (Washington, Clackamas, Multnomah Counties in Oregon and Clark county, Washington), the Salem SMSA (Marion and Polk counties), and the Wasco-Sherman labor market area (Wasco and Sherman counties) are presented separately (page 86).

Because of unusually high rates of growth, certain indicators in certain counties would not fit on the appropriate page. For example, personal income and per capita income in Gilliam county grew very rapidly between 1977 and 1982. Because of this, the Gilliam county income graphs and other graphs that would not fit on their respective county pages appear on pages 87 and 88.

Highlights

The years 1977-82 were for Oregon a period of moderate growth in population and employment during the early years and modest declines in the final year of the period. It was also a period of rapidly increasing unemployment. Although per capita and total personal incomes increased in nominal dollars, real incomes declined during the period as inflation eroded the purchasing power of the dollar. This decline was selective, however, affecting only labor and proprietor income. Dividends, interest and rent income showed impressive growth in both real and nominal terms. Transfer income (primarily social security) also increased although at a slower rate.

The 1977-82 period was also one of declining county intergovernmental revenues (in real terms) and increasing property taxes (in real and nominal terms). The increases in property taxes reflect in part that costs increased faster than nontax revenue sources (primarily intergovernmental aid).

Although there is some variation in trends among the counties, the similarity is in many ways more striking than the differences. The similarity is more pronounced in the economic trends than in the fiscal trends. Because the counties vary significantly in their dependence on intergovernmental aid, and in the types of intergovernmental aid they receive, the greatest variation appears in fiscal indicators.

It is likely that a study of these indicators will raise as many questions as answers. We believe that the multiyear perspective on economic and fiscal trends contained in this report will serve as a starting point for a better understanding of your county's local economic and fiscal situation.




PERCENT UNEMPLOYED




PER CAPITA INCOME (\$)




PERSONAL INCOME (\$000,000)




PERSONAL INCOME, 1977 DOLLARS (\$000,000)




RETAIL SALES (\$000)




NET PROPERTY TAX LEVY (\$000)
